INFORMATION PURSUANT TO EU REGULATION 2016/679 ON DATA PROTECTION

Pursuant to Articles 13 and 14 of EU Regulation 2016/679, we hereby inform you of the methods for collecting and using the data provided.

- Data is collected exclusively for the management and reporting of activities and is entered into the information system of the Autonomous Region of Sardinia (RAS) to be processed by authorised personnel.
- The provision of data is compulsory and failure to provide it would make it impossible to manage the service's organisational and administrative processes.
- Data will be processed on paper, electronically and/or automatically and will be archived on RAS servers at the Direzione Generale della Difesa dell'Ambiente, (Via Roma 80, 09123 Cagliari). External parties will also be appointed as external data processors in accordance with article 28 of the regulation.
- Data will not be disclosed and can only be communicated to bodies/organisations that collaborate in the management of the activities or where there are regulatory or legal obligations.
- Data will be kept for the period required for the provision and reporting of the service, and in any case no longer than 5 years. It will not be disclosed in countries outside the European Union. Data will be managed in accordance with the provisions of Articles 15 to 22 of Regulation 2016/679 (right to access, rectification and erasure, processing restrictions, objection to processing...).
